### **Tribeca Investment Partners expands team with portfolio management and compliance hires**

He has extensive experience in the compliance field after spending the past five years as head of compliance and company secretary at APP Securities, the stockbroking subsidiary of AIMS Financial Group, a diversified financial services and investment group, active in the areas of mortgage lending, securitisation, investment banking and funds management.

Tribeca CEO and managing director, David Aylward, commented, “Angus is an experienced investment analyst with a strong track record and a welcome addition to the team. He has been known for many years to some of our senior staff who have regarded him highly as an industry peer.
